For race day trials all horses must be on course with identification papers and available for inspection by the start time of the second last race. Horses must have all gear in place prior to entering the mounting yard including the correct stirrup irons on the saddle.

For trials after races preference is given to horses requiring a barrier certificate or stewards clearance. For non-race day trials, all horses must be on course with identification papers and available for inspection by 9am. Trials commence at 9.30am. Jockeys must be on course by 9am and ready to mount for the first trial at 9.15am. For non-race day barrier trials, unless eight (8) nominations or more are received, barrier trials will not proceed.

The Club reserves the right to run additional trials on race days depending on circumstances.
