**RACE 5: SOUTH COAST OUTDOOR PRODUCTS BENCHMARK 55 HANDICAP 1200M**

App. M. Kinny (**Mr Burns**) was reprimanded under AR137A (5) (a) (ii) for using her whip on six occasions, one more than is permitted under the rule.

**RACE 8: REECE PLUMBING COMMUNITY CHRISTMAS CUP 1300M**

App. B. Loy (**Hello Schumann**) was reprimanded under AR137A (5) (a) (ii) for using his whip on seven occasions, two more than is permitted under the rule.

**RACE 1: HYGAIN BENCHMARK 64 HANDICAP (SCALED -1.5KG) 1300M**

**Unyielding**—When questioned regarding the performance of the gelding, rider J. Penza stated that whilst his mount overraced throughout the early and middle stages it was nevertheless disappointing in its failure to run on under pressure in the straight. A post-race veterinary examination of the gelding revealed no abnormalities.

**Ruthless Agent**—Bumped on jumping by *Force Of Magic*, which began awkwardly and shifted in.

Following the running of this race the track was upgraded to a good (3) at 2.05 p.m. to be made retrospective to include this event.

**RACE 2: TOMAKIN SPORTS & SOCIAL CLUB BENCHMARK 60 HANDICAP 1000M**

**Hosier Lane**—Slow to begin.

**Denman Dreaming**—Crowded on jumping between *Sky Mission* and *Cashenti*, both of which shifted ground.

**You're Kidding Me**—Slow to begin. Rider R. Bensley pleaded guilty to a charge under AR137A (5) (a) (ii) for using his whip on seven occasions prior to the 100 metres, two more than is permitted under the rule. In issuing R. Bensley with a fine in the sum of \$200, Stewards took into consideration his poor record in relation to breaches under this rule.

**RACE 3: AUSTRALIAN HEALTH & SAFETY SERVICES CLASS 1 HDCP (SCALED -1.0KG) 1200M**

**Poet's Advocate**—When questioned regarding the performance of the gelding, which was resuming, rider R. Bensley stated that his mount travelled well throughout the early and middle stages and whilst rounding the home turn it was contacted by *Motime* and taken a little wider it nevertheless was disappointing in its failure to respond to his riding in the straight. A post-race veterinary examination of the gelding did not reveal any abnormalities.

**And There Is More**—Slow to begin. Passing the 250 metres, when attempting a narrow run between *Turbo Bundy* and *Rocky Marriage*, was contacted by *Rocky Marriage*, which shifted in.

**Rocky Marriage**—A little slow to begin. Raced greenly throughout. Passing the 250 metres shifted in and made contact with *And There Is More*.

**RACE 4: JUDY SHEA WEDDING CELEBRANT BENCHMARK 54 HDCP (SCALED -0.5KG) 1400M**

**Smiling At Shadows**—When questioned, rider App. R. Hunt stated that her instructions were to attempt to take up a position with cover. She added however that after being a little slow to begin and when runners drawn to her inside showed superior speed, she elected to come back and obtain a position closer to those runners. She added that in the middle stages the tempo was not overly quick and as a consequence for some distance after the 1000 metres she had to restrain her mount from the heels of *Diamond Charlie*, which lost ground. After obtaining a narrow run between *Bone Idle* and *Epinician* on straightening her mount, under pressure, nevertheless found the line reasonably well. A post-race veterinary examination of the gelding did not reveal any abnormalities.

**Epinician**—Near the 900 metres commenced to overrace and had to be steadied.

**Diamond Charlie**—After the 900 metres had to be restrained from the heels of *Epinician*, which lost ground.

**Path Of Justice**—Slow to begin and shortly after was tightened for room between *Diamond Charlie* and *Double Good*, which shifted in.

**Double Good**—Was held up and unable to obtain clear running rounding the home turn and in the early part of the straight. Near the 250 metres, when disappointed for a run between *Liabilityadjuster* and *Mr Fox*, was angled to the inside of the heels of *Mr Fox* to obtain clear running.

**Liabilityadjuster**—Was contacted on jumping by *Obilic*, which shifted out. Raced keenly in the middle stages of the event.

**Bone Idle**—Trainer Mr D. Bailey was fined the sum of \$50 under AR140A for presenting the mare in the mounting enclosure without its nose roll.

**Alba Gu Brath**—Obliged to race wide throughout.

**RACE 5: WOMEN IN RACING MAIDEN PLATE**

**1000M**

**Glowing Pioneer**—Began awkwardly.

**Rosover**—Tightened shortly after the start by *She's The Ticket*, which shifted in slightly.

**Lease Of Life**—When questioned, rider M. Bell stated that his mount was slow to begin and also to muster speed and as a consequence raced further back than anticipated, however had run on reasonably well in the straight under pressure.

**Paradiso Girl**—Trainer Mr N. Olive was fined the sum of \$50 under AR140A for presenting the filly in the mounting enclosure without blinkers after the filly had trialled twice with that gear and therefore was required to race in that gear. Raced wide throughout.

**RACE 6: MICK PICKER'S LAST GALLOP MAIDEN HANDICAP**

**1400M**

**Faith In Beers**—Began awkwardly and lost ground (3L).

**Cristallo Rosso**—When questioned rider M. Bell stated that with the apparent lack of pace in the event his mount took up a more forward position today. He added that whilst his mount overraced in the middle stages of the event it was nevertheless disappointing in its failure to run on in the straight. A post-race veterinary examination of the mare revealed

**Revenue**—Rider B. El-Issa was reprimanded under AR137A (5) (a) (ii) for using his whip on six occasions prior to the 100 metres, one more than is permitted under the rule.

**Double Action**—A post-race veterinary examination of the gelding revealed no abnormalities.

**Her Name Is Rio**—Slow to begin.

**Holy Stilettos**—Raced keenly in the middle stages.

**My Foolish Notion**—After being loaded, and due to a malfunction, the gates opened resulting in the mare cantering a short distance before being pulled up. The mare was examined by the club's veterinary officer and passed fit to start. The gates were then re-tested prior to the field being loaded for this event. On straightening was bumped on the hindquarter by *Her Name Is Rio*, which shifted in slightly. Was held up for clear running from the 300 metres and until passing the 200 metres and for some distance thereafter its rider attempted to bring the mare to the outside of the heels of *Tip Jar* to obtain clear running.

**Sunwisp**—Bounded on jumping and lost ground (3L).

**The Storyteller**—A post-race veterinary examination of the filly revealed no abnormalities.

**Tip Jar**—Passing the 150 metres came into contact with the hindquarter of Faith In Beers, which shifted in marginally and as a consequence of that contact then had to be steadied when that runner was turned in across the running of the filly.

**RACE 7: BLACK OPAL BOOKINGS CLASS 1 & MAIDEN PLATE**

**1600M**

**Ariake Fire**—Passing the 500 metres had to be steadied when briefly tightened for room between *Bristling Ocean* and *Calabash Express* (A. G. Robinson), which shifted in slightly. A. G. Robinson was advised to exercise more care.

**Addicted To You**—A post-race veterinary examination revealed the mare to be lame in its off foreleg. Trainer Mr K. Burn was advised that he would be required to provide a veterinary clearance prior to racing again.

**La Vitesse Rush**—Passing the 1300 metres had to be steadied from the heels of *Bristling Ocean* (C. Lever) which shifted in when not quite clear. C. Lever was advised to exercise more care.
